## MA 151 - Calculus for Elementary Education I

Section 001 **Spring 2019 3 Credit Hours** 

## **Course Description**

Calculus for Elementary Education I is the first semester of a two semester sequence of courses designed for the Elementary Education Program. Topics will include sequences, limit, and derivative. Also, topics related to teaching elementary mathematics will be discussed. Students cannot receive credit for more than one of MA 151, MA 121, MA 131, or MA 141. MA 151 is not an accepted prerequisite for MA 231 and MA 241. This course is restricted to Elementary Education majors only.

## **Learning Outcomes**

- 1. Participate in learning tasks that focus on different approaches to introduce and work with concept of calculus.
- 2. Actively learn mathematics that is based in calculus, but also supports elementary mathematics.
- 3. Use technology when appropriate to further their own understanding and prepare for using technology when they become a teacher.
- 4. Understand rate of change, function, differentiation, and integrations, from both a conceptual and computational perspective.
- 5. Enhance their problem solving skils and work on intepreting the mathematics in a real context.

The class will consist of short lectures on various topics, but a majority of class time will be dedicated to problem solving in small groups.
