1. Check to ensure sure you meet the membership requirement for eligibility. This can be achieved several ways:
 1. Your home institution is an institutional member of CUR. Check the [Institutional Membership Directory](#)
 - a. NC State University is an Enhanced Institutional Member of CUR and students submitting an abstract should **use North Carolina State University** in the submission.

2. The institution where you performed your research is a member of CUR. Check the [Institutional Membership Directory](#)
3. Your faculty advisor is a member of CUR. Check the [Individual Membership Directory](#)
4. If you are not sure of your institutional or faculty advisor membership status, please contact [Janae Douglas](#), Membership Coordinator.

3. Ensure all individuals that will be listed on your application have created an account using the link on the login page.
4. Submit your application via the online portal by November 5, 2019 at 11:59 pm EST. Late submissions will not be accepted.
