# **Course Description**

(3-credits) A single semester calculus course. Emphasis on concepts and applications of calculus and basic skills. Algebra review, functions, graphs, limits, derivatives, integrals, logarithmic and exponential functions, functions of several variables, applications in management, and applications in biological and social sciences.

# **Learning Objectives**

By the end of this course students should be able to:

- 1. Differentiate simple and more complex functions
- 2. Apply rules of differentiation
- 3. Maximize and minimize functions of single and multiple variables
- 4. Integrate functions and apply several techniques of integration
- 5. Perform complex analysis of functions
- 6. Apply calculus methods to basic real-world problems
